In 1998 Elaine created the "Cookie House," an after school tutorial program for kids. In 1999, in her capacity as an education reporter, she organized a weekend trip to Space Camp in Canada for 30 educators. The goal was to help the teachers encourage their students to pursue careers in science and exploration.

Elaine has a remarkable talent for being able to communicate with young people. Much of her spare time is spent traveling to schools, meeting with and talking to young people. In fact, she makes it a priority to talk to kids at whatever location she finds them, whether it is in residential homes or behind bars at the New York State Division for Youth in Johnstown.

In June 2009, Elaine earned her Masters Degree in International Women's Studies from SUNY's Empire State College.

In May of 2009, Elaine was honored with the School Administrators Association of New York's "Friend of Education Award" for her dedication and commitment to education issues and Capital District students and schools.
